1	<p>1.a</p> <p>Consignment complies with Annex VII, point 68c of Commission Implementing Regulation (EU) 2019/2072. Fruits of <i>Solanum aethiopicum</i> originate in a place of production established by the national plant protection organization of Uganda as being free from <i>Neoleucinodes elegantalis</i> (Guenée) in accordance with the relevant International Standards for Phytosanitary Measures and official inspections have been carried out in the place of production at appropriate times during the growing season to detect the presence of the pest, including an examination on representative samples of fruit, shown to be free from <i>Neoleucinodes elegantalis</i> (Guenée), and information on traceability is included in the phytosanitary certificate referred to in Article 71 of Regulation (EU) No 2016/2031. The consignment complies with Commission Implementing Decision (EU) 2021/869 Amending the conditions laid down in Article 4 c of Commission Implementing Decision 2018/638/EC; the fruits of <i>Solanum aethiopicum</i> are not from a country or area recognized as free from <i>Spodoptera frugiperda</i>, but they comply with the following conditions: (i). They have been produced in a production site that is registered and supervised by the National Plant Protection Organization of Uganda; (ii). Official inspections have been carried out in the production site during the three months prior to export, and no <i>Spodoptera frugiperda</i> has been detected; (iii). Prior to export, the produce has been subject to an official inspection and found to be free from <i>Spodoptera frugiperda</i>; (iv). There is full traceability covering all movements from the place of production to the point of export; (v). The specified plants have been produced in a production site which has complete physical protection against the introduction of <i>Spodoptera frugiperda</i>. The consignment complies with Option (c) of Annex VII, Point 72.1 of Regulation (EU) No 2021/2285: no signs of <i>Bactrocera latifrons</i> (Hendel) have been observed at the place of production and in its immediate vicinity since the beginning of the last complete cycle of vegetation, on official inspections carried out at least monthly during the three months prior to harvesting, and none of the fruits harvested at the place of production has shown, in appropriate official examinations, signs of <i>Bactrocera latifrons</i> (Hendel) and information on traceability is included in the phytosanitary certificate.</p>
